PETITION FOR NATURALIZATION (Filed under Section 701 of the Nationality Act of 1940)

This petition for naturalization, hereby made and filed, respectively shows:

I am attached to the principles of the Constitution of the United States and well disposed to the good order and happiness of the United States. It is my intention in good faith to become a citizen of the United States, and to reside permanently therein.

(11) Submitted herewith as a part of this, my petition for naturalization, are the affidavits of at least two verifying citizen witnesses required by law.

(12) Wherefore, I, your petitioner for naturalization, pray that I may be admitted a citizen of the United States of America, and that my name be changed to Leo Camp
